Closing time for Eligibility Exemption Requests:

LP11 Round 1: 5.00 pm (AEDT), Wednesday 31 March 2010

LP11 Round 2: 5.00 pm (AEST), Wednesday 29 September 2010

- Each ARC online application system pre-submission Eligibility Exemption Request should relate to a **single eligibility issue only**.
 - For cases involving more than one Partner Organisation requesting an exemption from providing the minimum cash contribution, you **MUST** submit a separate Eligibility Exemption Request for each Partner Organisation involved in a Proposal.
 - Each Eligibility Exemption Request must be reviewed and submitted by the Research Office of the Administering Organisation.
 - The minimum combined Partner Organisation Cash Contribution is required for each Proposal unless all Partner Organisations have been granted a 'Partner Organisation Minimum Cash Contribution' Eligibility Exemption.
 - **Relevant additional information to support each Eligibility Exemption Request should not exceed 5 pages, as per the Instructions to Applicants for Eligibility Exemption Requests.**
 - For each Partner Organisation which is the subject of an Eligibility Exemption Request regarding provision of the minimum cash contribution, please ensure the pro forma provided below is completed and merged with all supporting documentation in a single PDF, as per the Instructions to Applicants for Eligibility Exemption Requests.
