

# Acknowledgement of ARC funding and logo use

The Australian Research Council (ARC)'s Funding Agreements require grant recipients to appropriately acknowledge ARC's contribution to research and other activities. The ARC logo should be included in this acknowledgement.

Permission to use the ARC logo must be granted by the ARC. To request permission, email <a href="mailto:Communications@arc.gov.au">Communications@arc.gov.au</a> with details of the ARC-funded project and how the logo will be used.

## **Using the ARC logo**

In using the logo, you must comply with the <u>Australian Government Branding Design Guidelines</u> about placement, colour and size requirements. For example, the printed Australian Coat of Arms must be a minimum of 20mm.

When approved, the ARC will provide you logo files for both stacked (above) and in-line (on right) versions in a range of formats. We recommend you use EPS or TIFF for print media, GIF for web and JPEG or GIF for Microsoft Office.

# When and how to acknowledge ARC funding

Any ARC contribution to research and other activities should be acknowledged in line with the Grant Agreement.

When the researcher or any other party publishes or produces books, articles, newsletters or other literary or artistic works relating to the project, the Administering Organisation must ensure that ARC support is acknowledged. Where the Research Output is a publication, the Project ID must also be included and the acknowledgement should mention the ARC as a funding body.

ARC-funded Centres of Excellence, Special Research Centres Hubs and other Centres should include "Australian Research Council" or "ARC" in their titles and have the ARC logo in a prominent location on their websites and promotional materials. Researchers awarded an ARC fellowship should acknowledge that fellowship. For example:

- This research was funded (partially or fully) by the Australian Government through the Australian Research Council (ARC). Professor XXX is the recipient of an ARC Australian Laureate Fellowship/Discovery Early Career Award/ (project number XXXX) funded by the Australian Government.
- This research was conducted by the ARC Centre of Excellence/ARC Special Research Centre/ARC Key Centre for XXXX (project number XXXX) and funded by the Australian Government.

#### **ARC stickers**

The ARC can provide free small (375 x 150mm) and large (745 x 300mm) stickers to promote projects. Email Communications@arc.gov.au to request physical stickers or the file to print your own.

### Distinguishing your views from the ARC

In recognising ARC funding, you should make it clear that views or messages do not represent the Australian Government or the ARC. If a material or publication contains a message or view which could be interpreted as being from the ARC, and which has not been officially endorsed by the ARC, please specify this. For example:

- This research was supported (partially or fully) by the Australian Government through the ARC's Discovery
  Projects funding scheme (project DP0XXXXX). The views expressed herein are those of the authors and are
  not necessarily those of the Australian Government or the ARC.
- This research was conducted by the ARC's Centre of Excellence/ARC Special Research Centre/ARC Key Centre for XXXX (project number XXXX). The views expressed herein are those of the authors and are not necessarily those of the Australian Government or ARC.
